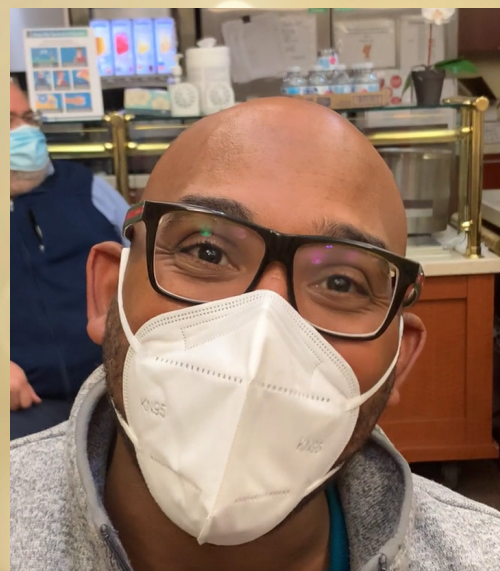

St. Paul's Diversity, Equity, and Inclusion (DEI) Initiative



After the tragic murder of George Floyd, communities and organizations across the nation looked for ways to improve Diversity and Equity and ensure Inclusion (DEI) to better respond to the inequities in our society. St. Paul's joined in these efforts and we have now been able to engage a consultant to assist with our DEI efforts over a two year period. LeadSelf Consulting provided the winning bid for these services and Curtis and Angela Robinson are the lead consultants that will guide this effort for St. Paul's. This work will also be overseen by the DEI Steering Committee and St. Paul's Administrative Team.

Some of the areas that will be addressed include:

- Review of our hiring practices to ensure we are attracting a diverse work force.
- Assisting with creating clear career pathways for staff wishing to advance within the organization.
- Reviewing our Gallup employee engagement survey results to identify areas of strength and ways in which we can improve engagement.
- Training for St. Paul's leadership team (all those who supervise) on both "Inclusive Leadership" and "Implicit Bias."
- Development of a two-year roadmap to develop measures and a plan for ongoing work.



The LeadSelf team has completed interviews with steering committee members and the Administration Team. They have hosted focus groups with employees in order to better understand current issues brought forward by our team members.

St. Paul's PACE Wellness Center:

CREATING SPACE FOR BEHAVIORAL HEALTH

In the spring of 2022, St. Paul's PACE opened the doors to its first Wellness Center, a centralized space dedicated to serving the behavioral health and wellness needs of PACE participants throughout San Diego. At the Wellness Center in Bankers Hill, PACE participants can come from any location in San Diego to visit with their clinician face-to-face to experience the benefits of in-person counseling.



Brian Mullin, LCSW and Behavioral Health Manager at St. Paul's PACE, said, "The intention of developing this center is to centralize all of our behavioral health services and create a space for our participants that feels like a community clinic. The feedback from participants has been very positive."

Currently, the center has two licensed clinicians, three participant care coordinators and is actively recruiting additional team members. St. Paul's plans to expand services to include group classes that stimulate and support the whole person. Brian and his team have developed "Pillars of Wellness" to support all-inclusive participant care.

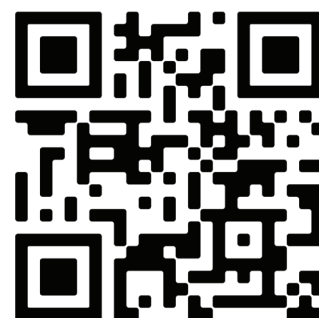
"Karen will add tremendous value and make key contributions to developing and improving our culture here at St. Paul's," said Tim Frazier, Chief Administration Officer.

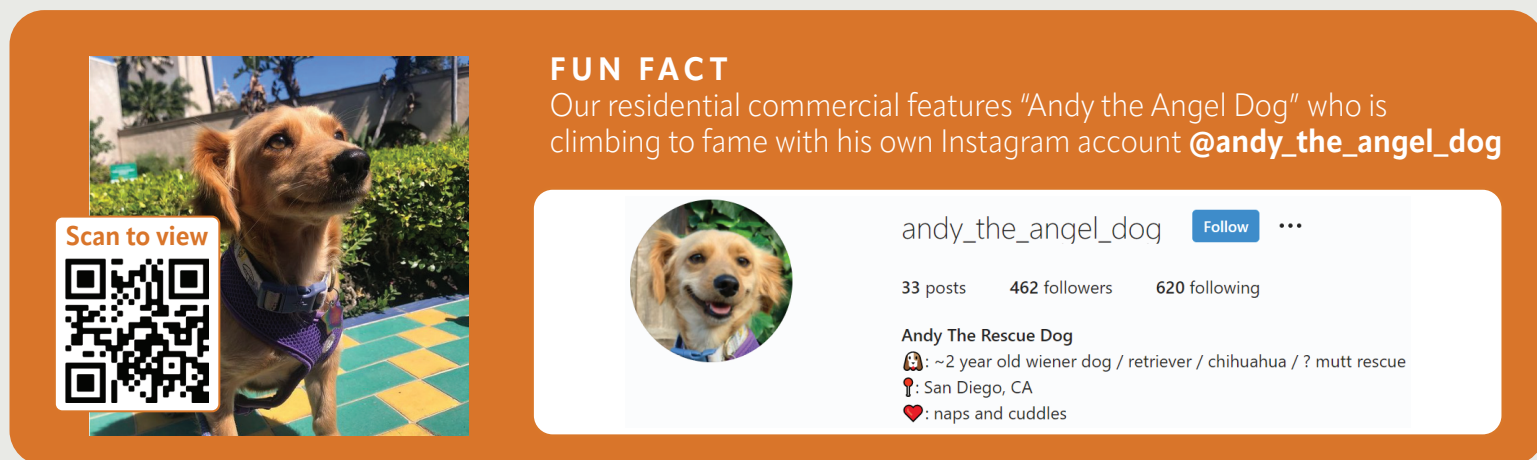

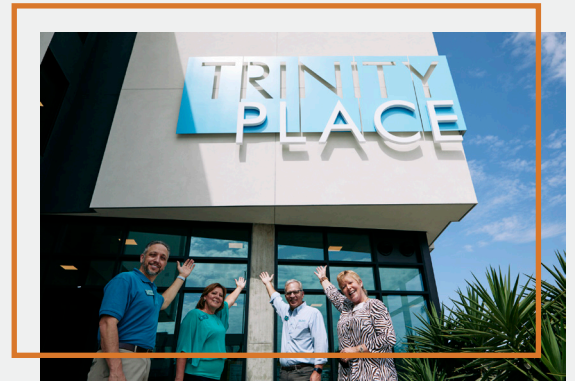
